The President of the Republic of Kosovo,
Pursuant to Article 84 (28) of the Constitution of the Republic of Kosovo, Article 6 of Law No. 03/L-094 on the President of the Republic of Kosovo (OG, No. 47, 25 January 2009), Articles 5 and 18 of Law No. 04/L-070 on the grant of decorations by the President of the Republic of Kosovo (OG, No. 02, January 20, 2012), Article 3 (4) of Regulation (P) 02/2016 on the Organizational Structure of the Presidency (08.09.2016), and taking into account Article 4 (2) of Regulation (P) No. 04/2016 on the types of decorations and procedures for awarding and revoking them (21.12.2016), issues:

**REGULATION (P) NO. 02/2018 ON THE TITLE: GOODWILL
AMBASSADOR**

CHAPTER I – GENERAL PROVISIONS

**Article 1
Aim**

This Regulation defines the criteria and procedures for awarding and revoking the Title: Goodwill Ambassador.

**Article 2
Scope**

This Regulation shall be applied during the process of awarding or revoking the Title: Goodwill Ambassador

**Article 3
Definitions**

1. The expressions used in this Regulation have the following meaning:
 - 1.1. **President** – The President of the Republic of Kosovo;
 - 1.2. **Minister** – Minister of the Ministry of Foreign Affairs;
 - 1.3. **Goodwill Ambassador** – which is a title, granted by the President;
 - 1.4. **Revocation of the title** – the revocation of someone's right to carry the granted title by the President;

- 1.5. **Department** – Department for Legal Issues and International Relations within the Office of the President;
 - 1.6. **Officer for Decorations** – The relevant officer for decorations within the Department;
 - 1.7. **Commission** – Evaluation Commission for Decorations appointed by the President in accordance with Regulation (P) No. 05/2016 on the work of the Evaluation Committee for Decorations (21.12.2016);
 - 1.8. **Law** – Law No. 04/L-070 on the grant of decorations by the President of the Republic of Kosovo (OG, No. 02, January 20, 2012);
 - 1.9. **Regulation** – Regulation (P) No. 04/2016 on the types of decorations and procedures for awarding and revoking them (21.12.2016).
2. Other terms used in this Regulation have the same meaning as in the definitions of the Law and the Regulation.

CHAPTER II – CRITERIA AND PROCEDURES FOR THE GRANT OF THE TITLE: GOODWILL AMBASSADOR

Article 4 The criteria

1. The Title: Goodwill Ambassador is granted to persons, who:
 - 1.1. advocate for certain issues in a country or organization, based on their goodwill;
 - 1.2. have been and are in the service of the general interest of the society and the Republic of Kosovo;
 - 1.3. have provided and will contribute to the development of arts, culture, science, sports and/or diplomacy as well as in other areas of public life;
 - 1.4. promote the empowerment of the international subjectivity of the Republic of Kosovo;
 - 1.5. support the membership of the Republic of Kosovo in International Organizations and Mechanisms; and
 - 1.6. support the process of recognition of the Republic of Kosovo.

Article 5 The grant of the Title

The President, on his/her own initiative, can grant the Title: Goodwill Ambassador.

Article 6 Proposal for the Title

1. The proposal for the Title: Goodwill Ambassador, can be made by the Minister.
2. The Minister's proposal for the Title: Goodwill Ambassador, is addressed to the President in writing, and to it the following must be attached:

- 2.1. the appropriate reasoning, presenting the special achievements and merits of the proposed person;
 - 2.2. the consent of the proposed person, and
 - 2.3. the biography of the proposed person.
3. The proposer is responsible for all the data and evidence submitted for the proposed person.
 4. The proposal of the Minister, addressed to the President, shall be transferred to the Department for further proceedings, unless the President decides otherwise.

Article 7

The review of the proposal for the Title

1. The proposals of the Minister, addressed to the President, for the grant of the Title: Goodwill Ambassador, are presented to the Commission for review by the Department, unless the President decides otherwise.
2. The Commission, in accordance with the Law and Regulation (P) No. 05/2016 on the work of the Evaluation Commission for Decorations (21.12.2016), reviews and evaluates the proposal and prepares the recommendation for the President.
3. In cases where the recommendation is approved by the President, the Department prepares the decision and the certificate.

Article 8

The mandate

The Title: Goodwill Ambassador is granted for a period of two (2) years, with the possibility of continuing with two-sided consent, based on the achievements and their goodwill.

Article 9

The handing over of the Title

1. The Title: Goodwill Ambassador is handed over according to the ceremony, on which the President decides.
2. Part of the award ceremony of the Title: Goodwill Ambassador may also be the Minister, in cases when the proposals are made by him.
3. The President may authorize the Minister or any other person to organize the award ceremony of the Title: Goodwill Ambassador.

Article 10

Revocation of the Title

1. The revocation of the Title: Goodwill Ambassador can happen in cases as follows:
 - 1.1. if the person, who has received this Title performs acts, which make him/her unworthy to carry it;
 - 1.2. if the person, who has received this Title acts contrary to public order and morality;

- 1.3. if the person, who has received this Title performs other acts which interfere with international rules, the Constitution and the applicable legislation of the Republic of Kosovo
2. The President, by Decision, revokes the Title: Goodwill Ambassador, under the conditions set forth in this Article.

CHAPTER III – FINAL PROVISIONS

Article 11 Records

1. The Title: Goodwill Ambassador, granted by the President, is recorded in a separate register, which is administered and updated by the Department, respectively by the Officer for Decorations.
2. The Officer for Decorations shall also keep records in cases of revocation of the Title

Article 12 Entry into force

This Regulation shall enter into force on the day of its adoption by decree by the President.
